## **CMU SAYS NO!**

"It is.. very clear to any student here who exists in a marginalized capacity that CMU does not have our best interests at heart. I have story after story after story from myself and other students, but CMU and Marshall will never take them seriously, mostly because they are anecdotal and they care about 'free speech'. Not to mention that Marshall has

said in many of my classes that anonymous feedback will not be heard by him because he doesn't respect anyone who won't tell him about a problem to his face. Which means that any student who is not willing to make themselves known and potentially become a target will not have their concerns heard."

"So I suppose the only thing that makes me feel sore is The Turning Point. They are directly against my beliefs. Now that they have had a hand in inviting Taylor, I feel as if it's clear where they really stand. Clubs should be allowed to exist but they also should be aware that people can and will disagree with them. Let's hope their arguments are sharp because I know mine will be."—CMU Student

"It's shameful that President John Marshall used such vague language in his letter to the school. I wish he would have explicitly condemned white nationalism, racism, and eugenics. I wish he would have explicitly stated his support and solidarity for our marginalized students.

I don't think it's a stretch to say that the demographic of people that uplift

this kind of rhetoric are also the kind of people that commit acts of domestic terror. It makes me feel less safe as a student when I'm on campus as someone with anti-racist, feminist, and anticapitalist values.

There is a palpable bias in the types of speakers that CMU and clubs bring to campus. I want

to see that change. I want marginalized groups like differently able students, students of color, atheist students, and the like to start inviting people to speak on campus that represent real CMU values."

# **CMU Fostering a Climate of Hate**

A new campus club, the "Western Culture Club," appeared on campus in early March promoting a talk by Jared Taylor to be held at Colorado Mesa University later in March. Taylor is an avowed white supremacist and author, and this is just the latest escalation by bigots on campus, seemingly with the blessing of the CMU administration.

When students started a new semester at Colorado Mesa University in Grand Junction on January 20th, the same day that Trump took office, the campus seemed different.

Emboldened by the inauguration of an openly racist and openly fascistic president, racist students on the campus have begun a now months-long sticker campaign. The stickers call on students to fulfill "civic duty" to "report any and all illegal aliens" to Immigrations and Cus-

toms Enforcement.

The design of the sticker dates back to a sticker and poster campaign in 2018 by Vanguard America (VA), which first appeared in Queens, New York. VA has since rebranded as Patriot Front, after a VA member drove their car into a crowd of counter-protestors at the 2017 "Unite the Right" rally in Charlottesville, North Carolina, killing Heather Heyer and injuring 35 others. This will tie in later; just remember the stickers on campus are tied to a group that has carried out terrorist attacks and is now known as Patriot Front.

The first stickers went up on CMU campus just days after the inauguration, and then "they became very widespread in the beginning weeks of February," said a CMU student we are going to call Ezekiel. Sightings of stickers increased

in frequency in the first days in February and coincided with the student group Turning Point USA hosting an ongoing series of controversial 'gotcha' polls. Polls like "Can a man become a woman?," "Do you

support Mass Deportation?," and "Should Free-Speech protect Hate-Speech?"

Turning Point USA is a national conservative non-profit that promotes far-right political ideologies in high schools and colleges around the nation. Founded by Charlie Kirk in 2012, both Kirk and the organization have since regularly sparked controversy with their close ties to the alt-right and their own racist rhetoric.

Another student wrote to Diers: "I am fully aware that [TPUSA-CMU] being

there is free speech and was approved through proper channels, but let's not act like them spewing hate speech and actively verbally and physically harassing students is okay. Is CMU aligned with their actions by allowing this to continue on campus property?"

The concerned student continued, "Hatespeech is not protected in free speech when it's used to confront specific people in a face-to-face matter... It is clearly understood that hate speech is defined by hateful, harmful, and dis-(Patriot criminatory language diwhich is exactly what's happening here."

Additionally, free-speech doesn't protect "fighting words," according to the Supreme Court in their 1942 decision,

Chaplinsky vs New Hampshire. Fighting words are words said in public that are likely to incite violence, and they are their own crime: disorderly conduct. Denying whole groups the right to exist sure seems like fighting words to us at The Rev.

Students have yet to get a response from CMU President John Marshall, about the stickers and the gotcha polls, but he did release a statepremacists

## **CMU Student Body Response**

The Colorado Mesa University student body is deeply disappointed and aggravated by the decision made by president Marshall to permit white supremacist Jared Taylor to speak on campus. President Marshall claims this decision best reflects CMU's 7 values, vet agrees Jared Taylor stretches their limits.

To our president, this speaker is a test to CMU's resiliency of hate and upholding of dignity. But to our community, it is a warning about a growing epidemic of hate that must be contained. President Marshall misunderstands the founding fathers' purpose of the first amendment. Free speech is not an encouragement for violence. Free speech is the ability to criticize and defend our individual freedoms, while not demoralizing the livelihoods of our neighbors.

The illusion that white supremacy falls under free speech elects rapists to the white house. In already unprecedented times, President Marshall has demonstrated he will stand on the sidelines of racism. John Marshall, reverse your decision or forever stain your legacy on this campus.

They are public officials serving in a public role, but please be diplomatic, they are not behind any of this controversy, and they could stop it! It also contains contact for submitting a letter to the editor to the Crite or the Daily Sentinel. Make your voices heard.

#### Talking Points:

"Where Jared Taylor goes, violence, harassment, and intimidation follow. His American Renaissance Conference draws groups known for mob violence from around the country and the world. An event organized by a student club at Arizona State University cost the University over \$11,000 in security fees. (See source 1)"

"Our community has seen multiple incidents of racial violence over the last year, and many more in the preceding years, including a recent assault against a news reporter, a viral video of racist harassment at Five Guys, anti-Semitic flyers with threatening messages dropped in people's yards, and Patriot Front graffiti. Does the college want to continue to promote racist violence in our community?"

"Jared Taylor hosts the American Renaissance Conference every year in Montgomery Bell state park near Nashville. TN. Attendees include the violent hate group Patriot Front, many of whose members were arrested in an attempt to attack a Pride festival in Idaho. Do vou want to encourage that kind of mob violence in our city? On our college campus? (2)"

"Cities and towns near the American Renaissance Conference have seen a rise in activity from other violent groups like Blood Tribe and GDL. GDL has already left flyers in residential neighborhoods in GJ attacking Jewish people. In Tennessee, they engage in violent assaults

of community members. Do you want to encourage this kind of violence here? (3)"

"When people think of Grand

Junction and Colorado Mesa University, do you want them to think of the art downtown, the Hotel Maverick and Devil's Kitchen, the Colorado National Monument, river rafting, and the Grand Mesa? Or do you want them to think of broken windows, masked men with swastika flags marching in the streets, and violent assaults against nonwhite people, our Jewish and Muslim

Rowdy seemingly endorsing TPUSA-CMU prompted even more emails and questions from students and the community of the CMU Pro-Life sticker from earlier this year. "This is racist stickers. Administration. So an anti-abortion lobby" is tagged over it. much so that an

official response from CMU was issued. "This was an error in judgment, and a mistake," wrote David Ludlam, Vice

Sasha was quickly pulled aside by Student Services and Maintenance and given a warning. "Were it not from my cooperation in taking my own stickers down, they would have given me a student conduct violation."

Jason Bias, the president of TPUSA-CMU, is more than a president of a student club. He has run two aborted campaigns for office and now serves as the co-chair of the Mesa County Republican Party. His social media accounts are awash in hateful and neo-nazi memes.

Patriot Front and its predecessor organizations have long been active in the Grand Valley and the college's campus.

Patriot Front used to be Vanguard America, the source of the sticker now showing up on campus. Vanguard America used to be National Vanguard, and National Vanguard used to be National Alliance. National Alliance was founded and run by TPUSA, Charlie Kirk, and the resegregation of America, or they are asleep at the wheel," said Ezekiel. "It's about time the CMU administration takes a side. Are they going to protect their students or are they going to roll over?"

The Rev has reached out to both the CMU Administration and Jason Bias for comment, and have not heard back from them by the time we went to print.
