

# A WHITEWASH WITHOUT PRECEDENT

**J**five years after the tragedy of 9/11, discrepancies about what really happened abound. Some come from surprising sources. One such resource is the new book by the co-chairs of the official bipartisan commission investigating 9/11; Republican, Thomas Kean, and Democrat Lee Hamilton. Their book is called, "Without Precedent."

The book is co-written in a third person style. The result of this technical decision is sometimes stilted, and occasionally discounting. Pushing through this though, you have an interesting read that reveals a great deal about the inner working of the Bush Administration. It offers little new information about the attacks or the motivation behind it.

"Without Precedent" serves largely to illuminate the difficulties the commission faced in coming up with a timely, accurate and truthful account of the 9/11 attacks. One message that came through loud and clear is that "we did the best we could with the time, tools, and resources we had available." The obstacles were considerable, especially considering that the Bush Administration stonewalled an official investigation from taking place at all, for over a year.

The scope of the investigation was simultaneously quite broad and yet, very narrow. The commission was to follow up on the actions (and inaction's) of numerous government agencies and bureaucrats. However, the list of perpetrators and co-conspirators was strictly limited to Al Qaeda. The fact that the United States C.I.A. funded, created, and trained Al Qaeda in the first place, was largely underplayed. Important intelligence and activity from regional heavy weights, such as Pakistan and Israel, was not included in their purview.

Kean and Hamilton admit mistakes were made quite regularly. Both state, that the questioning of former New York City mayor, Rudy Giuliani was "far too soft." They failed to ask tough questions, especially about the mysterious, often overlooked collapse of the World Trade Center 7 Building. "Questioning Giuliani was probably the low point of our investigation."

Certainly another low point they mention frequently is their dealings with President George W. Bush. All communications were directed through Attorney General Alberto Gonzales, who at that time was Bush's lawyer. "I have to protect the interests of my client," Gonzales would frequently intone as he denied access to important documents.

Bush regularly refused to testify before

the commission. When he finally agreed to be interviewed, he demanded a severely time constrained, closed door session. He demanded that Vice President, Dick Cheney accompany him, an unprecedented demand for a commission that interviewed only individuals. Both Bush and Cheney refused to be sworn in, under oath! Bush also demanded that no recording or even a transcript be allowed. The interview was reportedly curt and yielded a minimum amount of information. By contrast, it is instructive to recall that Congress demanded that Bill Clinton, at that time a sitting President, remove all his clothes for a physical exam during the Lewinsky scandal.

Another indicator of Washington's attitude towards the panel involved their funding. The space shuttle Columbia had recently disintegrated upon re-entry. Forty millions dollars were allocated to study what went wrong. The 9/11 Commission, investigating the worst attacks in history on American soil, was given a paltry 3 million dollars.

The most damning indictment of governmental irresponsibility lay squarely with the FAA and the Department of Defense. The FAA stonewalled the commission for months, restricting access to its employees until threatened with a subpoena. The agency also insisted that crucial transcripts and tapes of the events of 9/11 were either inadvertently destroyed, or never existed, depending on who was asked.

As for NORAD, the agency responsible for scrambling jets to protect us, Kean and Hamilton say, "we still don't know why they told us what they did." Then testimony crossed the line from inconsistent to inanity, to outright falsehood. Running out of precious time, the commission demanded that the Departments of Defense and Transportation conduct rigorous self investigations, a mandate that remains undone as of this writing.

The panel found that Iraq clearly had nothing to do with the attacks, something Bush has recently admitted himself. They did not recommend invading Iraq. Neither did they recommend the Patriot Act, or ordering the NSA to do widespread wiretapping of American citizens.

In fact, both Hamilton and Kean state that the Administration receives "Ds and Fs" for not following their recommendations. Kean says, "God help us if we get attacked again." Adds co-chair Hamilton, "We are not as well prepared as we should be."

## A BRIEF HISTORY OF FALSE-FLAG TERRORISM

Almost since the beginning of civilization governments have engaged in attacks on their own people to motivate them for war, or to give up their civil liberties, or both. In intelligence gathering parlance this is called false-flag operations. It is hard for people to think that the US government might have known about the attacks and let them happen, and harder still to think that elements of the government actively aided in the attacks, but history shows that governments attacking their own people is the rule rather than the exception.

Evidence is hard to come by from Nero's Rome, but it has been speculated by a number of historians that the burning of Rome in 64CE was actually set by Nero himself to prosecute the small Christian sects in the City. Whether the fire, which burned close to 70% of the city, was intentionally set or not, it's a fact that Nero blamed the fire on the Christians, and had most killed in the Arena.

Hitler was able to motivate his people to numerous preemptive wars and genocide through an act of false-flag terrorism. One week before the elections on the evening of February 27, 1933 the German Parliament building, the Reichstag, was set on fire. This arson, which the Nazi government blamed on communists, was used as justification for a mass crack down on civil liberties, and eventually for waging preemptive war in Europe. After WWII, at the Nuremberg trials, Nazi General Franz Halder stated in a legal affidavit that, "I heard with my own ears how [Herman] Göring broke into the conversation and shouted: 'The only one who really knows about the Reichstag building is I, for I set fire to it.'" *Rise and Fall of the Third Reich* by William L. Shirer.

The United States is not above killing our own people to provide justification for military intervention. Operation Northwoods was a Joint Chiefs of Staff plan from 1962 which detailed numerous situations to create "pretexts" which would provide justification for US military intervention in Cuba." These pretexts included: staging attacks on the US military base in Guantanamo Bay, sabotage and arson on the base, blowing up a US ship in Guantanamo bay, staging a communist Cuban terror campaign in Miami and Washington DC, and hijacking civil aircraft. The document also goes on to describe how to stage mock funerals for mock victims, adding "casualty lists in US newspaper would cause a helpful wave of national indignation." Thankfully JFK refused to enact this plan against the US people. ## THE EVIDENCE SAYS OTHERWISE

**(P)**On September 11th, 2001 the United States suffered the worst attack by domestic terrorists that it has ever endured. Many of you may be thrown off by the use of the term "domestic" in this article, but the basic evidence out there does not show a story of desperate religious zealots carrying out a major miracle in destroying three World Trade Center Towers and punching a hole in the side of the Pentagon. The physical, on the ground evidence shows a story of deception in which the largest miracle was the complete and blind acceptance of the American people. If you don't believe me, well I challenge you to refute the evidence below and if you still think that the American government had nothing to do with 9/11, well then I've got some ocean front property in Arizona that you may be interested in.

The impact of the planes could not have caused enough damage to bring down the buildings, since the buildings were designed to absorb planes, as Frank DeMartini, the project manager in charge of the construction of the World Trade Center has pointed out. This is but the first step in the physical evidence that points to other sources for the attack than those of Mid-eastern origin.

The melting point of steel is 2,800 degrees, which is about 1,000 degrees higher than the maximum burning temperature of jet fuel, which does not exceed 1,800 degrees under optimum air/fuel ratio's, so the fires cannot have caused the steel to melt, which means that melting steel did not bring the buildings down.

The steel in the buildings had been certified to withstand up to 2,000 degrees for at least six hours before it would significantly weaken. The fires burned about one hour in the south tower and one and a half in the North, much too short of a time to weaken the steel, much less melt.

If the steel had melted or weakened, the affected floors would have displayed completely different behavior, with some asymmetrical sagging and tilting, which would have been slow and gradual, not the complete, instantaneous total demolition that was observed.

There was not enough kinetic energy for the collapse of one floor to cause the next floor and subsequent floors to repeatedly collapse, one after another, all the way to the base of the towers. Heavy steel construction buildings like the twin towers, built with more than 100,000 tons of steel, are not capable of "pancake collapse" which can occur in concrete structures of "lift slab" construction and cannot occur in "redundant" welded-steel buildings, such as the towers, unless

every supporting column were removed at the same time.

The destruction of the South Tower in 10 seconds and the North in 11 seconds is faster than free fall with air resistance.

Pools of molten steel were found at the sub-basement levels, up to five weeks later, an effect that could not have been produced by the plane-impact/jet-fuel-fire/pancake collapse scenario.

47 story WTC-7 came down in a classic controlled demolition at 5:20 pm, after Larry Silverstein suggested the best thing to do might be to "pull it", industry jargon used to reference a controlled demolition. The sudden collapse of WTC-7 was so embarrassing to the official account that it is not even mentioned in The 9/11 Commission Report.

The hit point at the Pentagon was too small to accommodate a 100-ton airliner with a 125-foot wingspan and a tail that stands 44 feet above the ground; the kind and quantity of debris was wrong for a Boeing 757: no wings, no fuselage, no seats, no bodies, no tail! Which means that the building was not hit by the purported Boeing 757. The aerodynamics of flight would have made the official trajectory-flying at high speed barely above ground level-physically impossible; and if it had come in at an angle instead, a massive crater would have been created. The Pentagon's own videotape does not show a Boeing 757 hitting the building, as even Bill O'Reilly admitted when it was shown on "The Factor."

If flight 93 had come down as advertised, then there would have been a debris field of about a city block in size, but in fact the debris is spread over an area of about eight square miles. The above is only a beginners list of the discrepancies between what is known in growing circles, and that as published in the official story.
