

The ONDCP turned some heads when it was found out they had been "directly influencing" scripts for popular prime-time television shows, such as *Home Improvement* and *90210*. Congress had okayed a plan to spend \$1 billion dollars to buy anti-drug commercial space. But they requested that the networks sell their time at half price, in exchange, the ONDCP would sacrifice some of their ad time if the networks put anti-drug messages in their shows.

More than ever, we are being bombarded with anti-drug propaganda through TV, radio, and school. We are led to believe drug-users are bad people who need to be locked up or helped. There are strides being made, however. All ready eight states have legalized marijuana for medicinal purposes despite the fact the government has kept marijuana on the

list of Schedule I Drugs, ranking it with heroine, PCP, and LSD. California state and local governments continue to pass pro-medicinal marijuana laws. Marijuana is on its way to being decriminalized in Canada, following in the foot steps of the majority of Western Europe, many who've adopted a harm-reduction policy to drug use.



Silence is Golden

They say that truth is the first casualty of war, but in democracies we cannot afford that loss. A well-informed populace is key to a functioning democracy. With this current administration, secrecy has been top priority. Even before the terror of 9/11, this presidency sought to limit our right to know. Before 9/11, the Bush administration classified 33 million previously public records, and since 9/11 the classification of documents has kicked into overdrive—in what amounts to a war on truth. All wars are expensive; 5 billion dollars is spent annually by the federal government classifying, storing, and protecting sensitive documents; a 30% increase over the Clinton Administration. Granted, a certain amount of classification is necessary, but much of what is being classified today is overkill. Republican Rep. Peter Gross, Head of the House Intelligence Committee, said, "I read report after report after report all day, and they've got some type of classification cover on it. I'll say 'what's classified about it?'"

In a White House that is simultaneously stonewalling three federal investigations, secrecy is a way of life. Former Republican New Jersey Gov. Thomas Kean heads the independent commission investigating 9/11. Kean wants to interview the President, Vice-President, and other top officials. Kean has also threatened to subpoena the president's daily briefs. Because of the stonewalling the commission needs an extension on its May 27th deadline. The previous 9/11 commission also complained of non-cooperation on the part of the White House. When the first 9/11 report was finally released, the White House demanded that 28 pages be redacted, and it is widely believed that the redacted 28 pages pertained to Saudi Arabia. The White House is more subtly stonewalling the investigation into our pre-war intelligence; the President talks about the issue, but incomprehensibly so. In the January State of the Union Address, Bush said that Saddam had "weapons-of-

mass-destruction-related-program-activities." Whatever the fuck that means. Furthermore, the commission's report is not due until after Election Day—lucky for Bush—bad for democracy.

To be fair to this administration, they don't keep everything secret. Take for example, the grotesque pictures of Saddam's sons Uday and Qusay. Their bodies weren't even cold before the government propaganda machine got their pictures on every network and in every newspaper. Many watched the second Iraq war live on television. By using embedded journalists, the Pentagon could appear as though they were being open, but every image went past Pentagon censors. What we didn't see on CNN, MSNBC, or Faux News, was real war with real death. The Bush administration has also banned photos of the body bags coming home from Iraq. Former First Lady Barbara Bush in an interview with Good Morning America showed how well her son's propaganda has worked: "Why should we hear about body bags and deaths and how many... it's not relevant. So why should I waste my beautiful mind on something like that?" The most callous release of information was when a top White House official illegally leaked the identity of an undercover CIA agent as an act of retaliation against her husband. An investigation has been launched into who leaked the information to the media. Bush has expressed that the White House will cooperate, but that cooperation has not been forthcoming.

We should be suspicious of our government, especially when they operate more and more under a veil of secrecy. It is our duty to keep our government accountable, it is one of the checks and balances of our system, but accountability is impossible when every government file has "Top Secret" stamped on it, and the nightly news is cleared by a censor.

Who Really Were the 9/11 Hijackers

Just three days after the 9/11 attacks, the FBI released the names, photos, and personal details about the nineteen hijackers. When the list was released, FBI Director Robert Mueller said, "It is possible that the hijackers used false identities... If we have made mistakes then obviously that would be regrettable."¹ Apparently mistakes were made, but to date the FBI has not updated the names or photos. How did the FBI get these names? According to the official story all the hijackers were ticket holders who got past security with box-cutters. If they were ticket holders, their names or aliases would appear on the passenger lists. But the passenger lists as published by CNN, AP, and the *Boston Globe*, contain none of the names on the FBI list—or even any Arabic names.

The *Daily Telegraph* of London interviewed several of these men, who were upset about being identified as the perpetrators of 9/11.² If investigators do not know who the hijackers were, then they do not know their motives, history, or connections. If these were just stolen identities, why

doesn't the FBI figure out who they really were? If not, how do we even know that there were nineteen hijackers?

DARE to End the War on Drugs

As of February 21st, the government has spent an estimated \$5.6 billion funding the War on Drugs just this year. After the events of 9/11, the Ad Council began running ads proclaiming that by participating in drug use, even smoking a joint, one is contributing to and supporting terrorism. Considering about 50% of the marijuana consumed in the US is grown here, and the rest is imported, the majority coming from Mexico, second is Canada.
